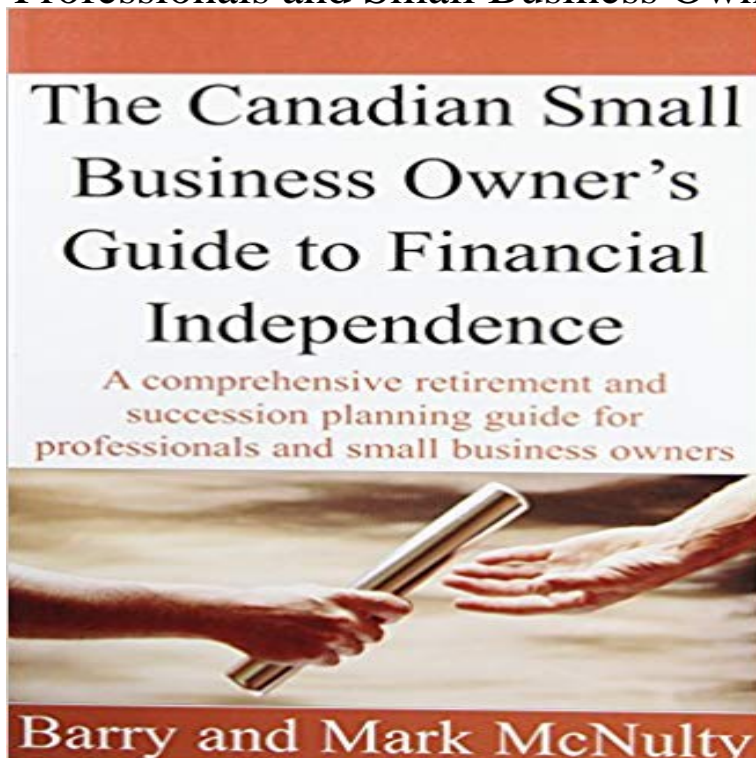


# Canadian Small Business Owners Guide To Financial Independence: A Comprehensive Retirement and Succession Planning Guide for Professionals and Small Business Owners
